- ➤ If you see anything going on in one state that you would like to see happen in your state, like a disability exception on taxes, contact your Congressman and AFSA so we can help lobby for it.
- > Military Retiree Survivor Comfort Act is currently on the hill to discuss the amount going to survivors
- Another plan to cut the Commissary budget by \$1.4 billion is out, it was cut \$1 billion last year.
- ➤ Disabled Veterans Tax Termination Act is currently out there to help military retirees with a service connected disability of at least 50% or more to obtain their retirement and VA benefits TAX FREE! VOTE today!
- > Senators are trying to give veteran status to our guard and reserve members, vot to help them gain the title!!
- ➤ Military Family Relief Act of 2015 and Repal or Modify the Former Spouse Protection Act are also out there to be voted upon!
